## **POLICE REPORT**

Swatara Township Public Safety Director, Darrell Reider stated 72 calls for service were placed for Paxtang. Fourteen traffic citations, 5 motor vehicle warnings, 1 traffic enforcement detail and 8 parking tickets were issued.

## POLICE COMMUNITY SERVICE REPORT

Swatara Township Officers participated in numerous community service events including the tree lighting ceremony for Paxtang Borough and the tree lighting ceremony for Swatara Township, and Shop with a Cop at the Walmart Supercenter located at 6535 Grayson Road. Shop with a Cop is a program where officers partner with the Harrisburg Police Athletic League and assist children with purchasing Christmas presents for their family members.

## **COFFEE WITH A COP**

Coffee with a Cop will be held on Thursday, February 13 at 9:00 a.m. at the Starbucks Coffee Shop located at 6301 Grayson Road . This event allows citizens the opportunity to meet with officers in a casual setting to discuss community matters of interest.

Councilman Wingert expressed his gratitude to Public Safety Director Reider for the increased presence of officers in the West end of the Borough. Director Ryder said Paxtang Borough is assigned their own separate Zone, will have a police officer assigned 24 hours a day, 7 days a week, 365 days a year, with increased visibility as needed. A round of applause was offered by those in attendance.

## **REPORT OF THE FIRE CHIEF**

Fire Chief John Tinari reported 24 calls for service were placed, 1 being in the Borough for a total manpower of 92 with an average crew response of 4. Time in service was 14 hours and 36 minutes. The Engine ran 16 calls, Rescue 10, Utility 0, Officer In Charge 0, and Fire Police 4. The call in the Borough was for a gas leak. There were two unanswered calls for the month. No trainings were held. Top five responders for the month of **December** were Chief Zwigart at 17, Firefighter Schaeffer at 14, Lt. Lemmon at 13, Deputy Fire Chief Tinari at 12, and Firefighter Frankenfield at 11. A year end report was provided with a breakdown of calls for 2019.

## **OATH OF OFFICE - SPECIAL FIRE POLICE**

President Bloss announced that Mayor Borne Fuller administered the Oath of Office of Special Fire Police to Sabrina Schaffer and Joseph Gilpatrick earlier this evening.

Councilman Wingert expressed his gratitude to Chief Tinari for the service provided by members of the Paxtang Fire Company. A round of applause was offered by those in attendance.

#### REPORT OF EMERGENCY MEDICAL SERVICES (STEMS)

President Bloss read for Council the Report of EMS as their representative was called away from the meeting to respond to a call. Nine calls for service was placed for Paxtang, 5 calls required lights and sirens, 4 calls required no lights and sirens. Average dispatch to at patient time for Advanced Life Support was 6 minutes and 38 seconds. The average dispatch to at patient time for Basic Life Support was 8 minutes and 1 second.

# 2016 AND 2017 MUNICIPAL SEPARATE STORMWATER SEWER SYSTEM DEPARTMENT OF ENVIRONMENTAL PROTECTION BEST MANAGEMENT PRACTICES IMPLEMENTATION FUNDING PROJECT

Engineer Smith said the Operation and Maintenance Agreements for the 2016 Prince Street/Park Terrace project and the 2017 Brookwood Street/Park Terrace project were executed by the City of Harrisburg and Paxtang Borough. Agreements have been recorded at the Dauphin County Recorder's office. A copy was sent to the Department of Environmental Protection. DEP stated the final reimbursement request would be processed and that the grants have officially been closed.

## **DERRY STREET SANITARY SEWER REPLACEMENT**

Ankiewicz Enterprises, contractor for the 29<sup>th</sup> and Derry Street sewer project, has been notified to address the seeding and soil issue in the Spring of 2020. If their final attempt is ineffective or they decline another undertaking, the Borough will hire a landscaper and deduct the cost from their remaining balance.

Mr. Lemmon introduced himself to Council as Captain of the Paxtang Fire Company, stating his comments brought before Council tonight were not done so as an official of the Fire Company. Mr. Lemmon was of the belief and opinion that Borough Council could have handled the appointments of the new Fire Chief and new Deputy Fire Chief in a more amicable manner. Mr. Lemmon was concerned that the short notice given to the former Fire Chief by Council regarding their decision not to reappoint him was not conducive to a smooth transition. Mr. Lemmon stated members of the Fire Company would ask that moving forward, Borough Council reach out and communicate with them for their input and wishes with regard to appointments.
